

# **Small Donations Program**

## Overview

MidCoast Council's Small Donations Program supports the delivery of community projects and activities that pursue our values of a connected community and unique, diverse and culturally rich communities.

Eligible organisations can apply for a small donation of up to \$150 at any time throughout the year. Only one small donation can be granted to an organisation or group during the financial year.

Applications will be assessed in line with Council's Donations Policy. Applicants will be notified of the outcome of their application within ten business days of receipt.

## Assessment criteria

#### What will be considered?

Applications from eligible organisations will be assessed with consideration to the extent to which the project or activity:

- meets one or more of the objectives of the Donations Policy;
- budget demonstrates good value for money and is comprehensive and realistic; and
- is supported by 'in-kind' contributions and/or additional sources of funding.

#### What won't be considered?

- Requests for funding for items related to the ongoing operations or administrative costs of a group or organisation such as uniforms, newsletters, utilities, stationery and wages.
- Requests for funding for events.
- Projects and services which duplicate core business of Council and/or state or federal government departments.
- Capital works requests on privately-owned land which benefit private or fee-paying membership patrons only.
- Applications for cash prizes for individuals or teams.
- Reimbursement of money that has already been spent or expenses that have already been incurred.
- Fundraising via direct requests for donations.
