**Proposal:** To amend the Greater Taree Local Environmental Plan 2010 by rezoning land at Blackhead Road, Hallidays Point from Primary Production (RU1) to General Residential (RI) and Environmental Conservation (E2) zones. This proposal will enable the residential extension of the Tallwoods Village and protect the ecological values of the site.

## Fox control

MidCoast Council (MCC) with support from the Hunter Local Land Services (LLS) in cooperation with adjoining neighbours will be undertaking 1080 fox baiting within:

- MidCoast Council land (Lot 5 DP 1089990, Lot 14 DP 1195303 and Lot 278 DP 753207 Tuncurry Waste Management Centre)
- MidCoast Council Water Division land (Lot 1 DP 1102051, Lot 164 DP 753207, Lot 10 DP 1160728, Lot 23 DP 1150979 and Lot 55 DP 753146 Darawank & Black Head)
- Holcim Tuncurry Sand Plant (Lots 79 & 120 DP 753207 Darawank)

The program will use 1080 bait mounds.

The program will be conducted from Monday 4 September and be completed by Friday 29 September 2017.

The use of 1080 mound baiting is conducted to help control the impacts of foxes on biodiversity values. All areas will have 1080 baiting signs erected on the main access tracks where the baiting is undertaken.
