Planning proposal - Livable Housing

Recognising growing community needs, we are proposing changes to the Great Lakes Local Environmental Plan to encourage the development of livable housing for all-ages and all-abilities, and provide more flexibility for development of land in urban release areas.

The Australian Livable Housing Guidelines assist in home design and certification of residences for a lifetime of living - including families with small children, people with temporary injuries. ageing baby boomers and people with disabilities. Developed by industry and the community, they provide assurance that a home is easier to access, navigate and live in, and less expensive to adapt when life's circumstances change.
