## 2018/19 beach vehicle permits

If you're a keen 4WD'er, now's the time to renew your beach vehicle access permit, which gives you the freedom to explore the coastline from a different perspective.

Annual permits are valid 1 July 2018 - 30 June 2019. A 30 day permit is also available for less frequent users.

#### On our roads and bridges

Keep an eye out for our maintenance and construction crews who continue to work in these areas:

- Blackhead Road reconstruction 620m either side of Federation Drive. Linemarking is programmed for this week and raised pavement markers to follow.
- Bulga Creek Bridge Works have commenced to replace timber bridge with new concrete structure. A side track has been established to maintain through traffic access.
- Pulteney Street, Taree Construction is continuing on both sides this week, with concrete works on the footpath, driveways and retaining wall. Both sides closed to general traffic. Project scheduled for completion late September.
- Mooral Creek Road, Strathcedar Gravel resheeting continuing with 3 weeks remaining.
- Manning Regional Art Gallery car park Works continuing to convert gravel car park into new concrete car park. Works programmed for completion mid-August.
- Hannam Vale Road, Hannam Vale Upgrading of a gravel road to bitumen sealed road. Two sections of road pavement totalling 1,800m west of Maynard Meadows Road.

With all roadworks please remember to travel safely. Observe roadworks signs and speed restrictions, note changed traffic conditions, and proceed with caution.

# **Bulky** waste collection

The bulky waste clean-up is continuing in the Manning region.

Remember to place your waste out on the kerbside (where you place your regular bins) on the date specificied for your zone in the schedule - no earlier, as this will be considered illegal dumping and you could be fined. Items must be sorted into two separate piles – one for scrap metal, and the other for general bulky waste. Visit our website for guidelines including what items will be accepted, and how your waste must be presented - noncompliant waste will not be collected and anything rejected and left outside your property is your responsibility to remove.

Note: electronic waste (eg, TVs, computers) is not accepted. Tip: If your unwanted items are in reasonable condition / working order, help us reduce the amount of waste going to landfill by trying to re-home them instead.
