Bulky waste collection

The bulky waste clean-up is underway in the Manning region.

Remember to place your waste out on the kerbside (where you place your regular bins) on the date specified for your zone in the schedule - no earlier, as this will be considered illegal dumping and you could be fined. Items must be sorted into two separate piles – one for scrap metal, and the other for general bulky waste. Visit our website for guidelines including what items will be accepted, and how your waste must be presented - noncompliant waste will not be collected and anything rejected and left outside your property is your responsibility to remove.

Note: electronic waste (eg, TVs, computers) is not accepted. Tip: If your unwanted items are in reasonable condition / working order, help us reduce the amount of waste going to landfill by trying to re-home them instead.
