As a road naming authority, to fulfill its obligations under the <i>Roads Act 1993</i> , Council is required to comply with the Geographical Names Board of NSW Guidelines for the Naming of Roads.						
In order for your name suggestions to be considered, you must provide three (3) new names and state reasons to support suggestions for each road. If possible, the history of the name/s should be included and the suggested names should have a maximum length of ten letters (excluding the suffix).						
Please note that Council will also exclude any proposed names which already exist in another town within the MidCoast area. Therefore, if you are unsure whether a particular name exists, prior to forwarding your application to Council, please contact Council's Engineering section on telephone no. 7955 7777.						
Documentation required (applicant to note) Please provide the following:						
 A proposed subdivision plan indicating the location of the new road must be attached to your completed road and bridge naming application form. 						
2. A Road Name Suggestions Sheet (attached to this application form) must be completed for each road being named.						
3. Spatial Extent description, including Start and End Coordinates (currently GDA94, MGA Zone 56, Easting and Northing) plus the total length of the road.

Advertising costs are required to be paid prior to Council's approval and release of the subdivision plans.
