Draft markets policy

We have developed a draft Markets Policy which relates to all regular markets taking place throughout the MidCoast region on Council owned land or Council controlled public land - including farmers markets.

Festivals and 'one-off' community based events and fundraisers such as annual markets and fetes occurring once a year, and markets taking place on private land will be excluded from this policy. They may however, be subject to a separate approval process such as a Special Event or Development Application.

The draft Policy is now on public exhibition and is open for feedback until 2 January.

On our roads and bridges

Keep an eye out for our maintenance and construction crews in these areas:

- **The Lakes Way, Bungwahl** - Reconstruction of 320m of road pavement south of Bungwahl.
- **Water Street, North Arm Cove** - Stormwater drainage works to rectify nuisance flooding issues, including the construction of a drainage pipeline and removal of the existing open drain.
- **Coomba Road, Coomba** - Minor pavement renewal works and replacement to existing stormwater pipes.
- **Crawford Street culvert, Bulahdelah** - Replacement of an old pipe culvert with a new box culvert.
- **Boondelbah Road, Tea Gardens** - Reconstruction works on 400m between Toonang Drive at both ends.
- **Reidsdale Road, Stroud Road** - Pavement reconstruction of 315m from the intersection with The Buckets Way.
- **Cape Hawk Drive, Forster** - Replacement of drainage approx 100m to the east of the intersection of Panorama Crescent and Cape Hawk Drive.
- **The Lakes Way, Charlotte Bay** - Pavement reconstruction works at the intersection of Boomerang Drive.
