Intended pesticide application

We have instructed Local Pest Experts to carry out pesticide applications in the Great Lakes Region, which are scheduled to be carried out during October and November 2019.

Pesticides are being used for ants, spiders and cockroaches. Pesticide products will be applied to Council structures including public buildings.

Pesticides used will be selected from: Biflex Aquamax insecticide, Synergy Pro ant bait, Starrdust Pro, Maxforce Gold Gel, Enviromax Deltamethrin, Temprid 75, Termidor.

Residents (including pets) are advised not to enter the premises through any treated areas until the pesticides used have dried, or any special instructions advised on the notice erected on the day(s) of treatment.
