Disaster welfare assistance

A disaster welfare assistance point is located at 68 Wynter Street Taree to support those impacted by recent bushfires.

The centre has been established by the NSW Government's Office of Emergency Management.

The Office of Emergency Management has advised the disaster welfare assistance point will operate as a base but will also be mobile to allow contact with some of the more remote impacted

This assistance point will provide access to a range of Government and non-Government services including Disaster Welfare Services, the Red Cross, chaplains, representatives of the Rural Adversity Mental Health Program and Rural Fire Service staff.

The disaster welfare assistance point will operate from 9am to 5pm Monday to Friday.

Water refill points for rural residents

Six temporary emergency water fill points have been installed for properties affected by the fires.

The supply points are located at

- 408 Bulga Rd Wingham 1 Coglan Ave Wingham
- 62 Mill St Krambach
- 1 Dibb St Nabiac
- 79 Beecher St Tinonee
- Gloucester Rd Nabiac

Residents in rural areas affected by fire can use these points to fill portable containers for essential domestic use.

Bulk water deliveries to refill water tanks on properties need to be separately arranged with a suitable water carting contractor.

Waste collections catching up

Normal waste collections have almost resumed, with collections made across the region late last week. There are still some areas that haven't had their rubbish collected. This will happen as soon as possible, once roads are deemed safe for the garbage trucks. Skip bins have been organised for a number of community halls in impacted areas. Herbicide spraying

We will be carrying out herbicide spraying during the months November, December 2019 and January 2020 in various waterways, open drains, and retention ponds within the entire Local Government area to target grasses, reeds, annual and perennial weeds.

As a precaution residents are advised to refrain from using, drinking or swimming in the water for two weeks following

Only qualified operators will be undertaking works. Herbicides Weedmaster Duo, Sixgun 360, Biochoice 360 and/or Glymac 360 (360g/L glyphosate) will be used as per the requirements of the label and APVMA off label permit 9907 where applicable.

This program is subject to weather conditions.

Scheduled areas will be assessed individually and treated as required. Individual areas will be sign-posted at the times of treatment in commonly accessed areas.
