Bulky waste clean-up

The scrap metal and bulky waste clean-up will take place again this year. It kicks off on Monday 29 April for residents in the Great Lakes region, with Manning to follow from 24 June, and Gloucester from 19 August.

You should check the date for collection in your specific zone, and place your waste out according to the schedule – no earlier, as this will be considered illegal dumping and you could be fined.

If you're a community group, event organiser, or own property in one of our heritage conservation areas, you could be eligible for community funding.

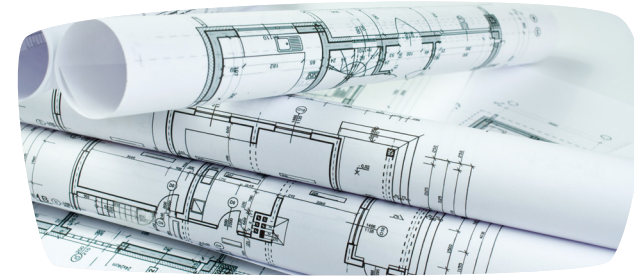
Applications are currently being invited for funding through our Community Donations program, our Event Sponsorship program, and the Local Heritage Fund.
