Health check for Wingham's Vampire Jet

A NSW Government grant of \$10,000 will contribute toward a 'check-up' for Wingham's iconic vampire jet. Scaffolding will be erected around the jet in October to enable engineers to undertake a detailed assessment of the integrity of the structure. While the scaffold is in place, repair works will be undertaken and the plane will be painted. Further funding from the NSW Government's Community War Memorial Funds will be allocated for repairs and maintenance of the Taree War Memorial Clock and the Nabiac Park War Memorial.
