Flood waste levy exemption ends soon

Anyone impacted by the March floods is reminded the flood waste levy exemption ends on 30 September.

This means any waste disposed of at our waste management centres after that date will attract the State waste levy.

If flood waste is disposed of before this date, the levy will not be charged.

Normal landfill fees still apply, and residents are required to prove the waste is flood impacted.

Senegal tea plant control program

As part of our ongoing commitment to the eradication of the Senegal tea plant in our region, we will be carrying out herbicide spraying from 12 October through to 4 December 2021 on the banks of the lower Barrington, Gloucester and Upper Manning Rivers.

Only qualified operators will be completing the targeted spraying using Weedmaster Duo, Biochoice 360, Sixgun 360 and/or Glymac 360. These herbicides contain 360g/L glyphosate which will be used, as per requirements of the label and APVMA permit 9907. This program is subject to weather conditions.

As a precaution residents are advised to refrain from using, drinking or swimming in the water for 96 hrs following treatments. Residents who pump from the river to fill water tanks for human consumption are advised to do so prior to commencement of works, and not resume pumping for 96 hrs following treatments.
