## Development proposal DA-171/2020



We have received the following Integrated development proposal:

- Property address: Myall Way, TEA GARDENS NSW 2324
- **Proposed development:** 741 lot subdivision (725 residential lots community title)

In 2019 we received an application for a 741 lot subdivision at Myall Way, Tea Gardens. Since that time the applicant has made some amendments to the proposed development, therefore we are re-notifying and re-advertising the development.

The amended development now includes a drainage easement in the southern part of the development site around the existing residential development, as well as a bushfire asset protection zone. The proposed commercial area in the south-western part of the site has been removed from the application as it requires additional studies to be undertaken prior to consideration. The applicant has indicated their intent to include that commercial area as a future development application.
