- **Restricted Funds policy** - this policy provides a framework for the establishment and management of Council's restricted cash funds.
- **Public Art policy** - the primary objective of this policy is to promote and facilitate quality and diverse public art initiatives in the region.
- **Code of Conduct** - Our Code sets the minimum standards of conduct for our council officials.
- **Market policy** - this policy ensures that there is a consistent process for allocating and managing licences for markets held on Council land or land under the care and control of Council.
- **Writing off Rates, Charges and Debts policy** - this policy establishes an amount above which debts to the council may be written off only by resolution of council and establishes the guidelines for the writing off of debts to Council in accordance with the Local Government (General) Regulation 2021.
